

PRIVACY STATEMENT

Protecting privacy and safeguarding the personal and financial information of our clients and Web site visitors is one of our highest priorities. The following Privacy Statement explains how we collect and protect your information. By opening an account or by using our Web site, you give your consent to the collection and use of personal information by us as explained in this privacy statement.

COLLECTION OF PERSONAL INFORMATION

Our company collects your personal information only with your consent and confidence in the security of your personal information on our project. SECURITY

Any payment transactions will be encrypted using SSL technology. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our Web site, you are responsible for keeping this password confidential.

We ask you not to share a password with anyone. 6.2.
